**Sub: Empanelment of agencies for Conceptualization, Fabrication, Maintenance and display of ICAR Tableau on Republic Day – reg.**

Reference is invited to the **Custom Bid (ref. no. GEM/2021/B/1460233 Dt. 23-08-2021)** for fabrication of Tableau for Republic Day. In this regard, it is informed that clause **'Evaluation of Bids'** of special terms and conditions may be read as:

*"A minimum of 50 marks shall be scored by a bidder in technical bid on the parameter as per Annexure I. The financial bid in respect of the successful technical bid only will be opened. The bidder having highest marks in total of technical and financial marks will be the H1 bidder."*

**Instead of:**

*"The bids will be evaluated on Quality and Cost Based Selection (QCBS) basis as per Annexure I. 40 % weightage will be given for technical bid and 60% weightage will be given for financial bid. A minimum of 50 marks shall be scored by a bidder in technical bid. The financial bid in respect of the successful technical bid only will be opened. The bidder having highest marks in total of technical and financial marks will be the H1 bidder."*
